Pliocene Ridge Community Services District (PRCSD) ardently supports Pike City Volunteer Fire Department's application for funding to install a fire escape and handicap ramp at the Pike Firehouse.

It should be noted that this building is the ONLY publicly owned building located within the Pike Community. In addition to housing the fire department's vehicles and equipment the building is also used for community gatherings and various trainings including: weekly fire department trainings, joint fire dept. trainings with other nearby departments and Red Cross Classes for both Emergency Responders and the general public.

PRCSD primarily acts as a Fire District for the communities of Pike City, Alleghany and Forest City and is the owner of the Pike Firehouse. The lack of a legal fire-escape for the upstairs room is a huge concern and creates a liability for the District. It has kept us from making the building available for non-department functions. Our annual budget of approx. \$35,000 is not sufficient to pursue this task without assistance.

PRCSD covers an area of approximately 130 square miles and serves a population of approximately 250 putting this application clearly within the demographics of the USDA Rural Development Community Facilities Loan/Grant program.
